WHEREAS, the Court has assigned the 31st day of May, 2023 at the Probate office, 17 Church Street, St. Albans, Vermont 05478, at 9:00 o'clock in the forenoon, to hear and decide upon said petition, and ordered that notice thereof be given to Jennifer Parker, A/K/A Jennifer Litch and Jennifer Southwick by publishing this notice in the Addison Independent, a newspaper circulating in Addison County, Vermont. A copy of this order as published shall be mailed to Jennifer Parker, A/K/A Jennifer Litch and Jennifer Southwick if an address is known.

THEREFORE, you are hereby notified to appear before said Court, at the time and place assigned, to make objections, if you have cause. If no one files an objection to the petition within 7 days of the hearing the relief requested may be granted.

This is the first action in this proceeding. If you wish to receive notice of all future events or motions which may occur in this matter you must enter your appearance in the proceeding with the court. This can be accomplished by returning to the court a completed Form No. 148 entitled "Notice of Appearance". The form can be found on the Vermont Judiciary website. You will then receive notice of all future events or motions as long as the proceeding is open and you remain an "interested person" as defined in Rule 17(a) of the Vermont Rules of Probate Procedure. If you have questions about the nature of this proceeding or the purpose or content of this notice, you may inquire by calling or writing to the petitioner, the petitioner's attorney or the register of the court. If you intend to contest the Will, please notify the register in advance to facilitate court scheduling.
